By acceptance of participation in activities of LYCI the undersigned agrees to the foregoing and also agrees that LYCI and Faith Evangelical Lutheran Church, their employees, and other representatives shall not be liable for loss, damage, injury, or inconvenience caused by or resulting from the malfunction of transportation equipment, strikes, acts of war or insurrection, fire, delays, theft or itinerary changes or cancellation.

If any conduct of the participant warrants them to be excused from participation in any event, I assume all responsibility for disciplinary action and picking up my child upon being notified by LYCI's representative, Sandy Becker, or her designee. Should it be necessary for the participant to return home due to medical reasons, disciplinary actions or otherwise, I hereby assume all transportation arrangements and costs.
